Show Rules

- CSE reserves the right to refuse entries from all locations within 150 miles which has had a confirmed outbreak of RCD/RHD/VHD within the past 60 days of the entry deadline.
- Open Sanctioned Show - OFFICIAL ARBA SANCTIONED SHOW, Membership Dues: \$20.00 per yr., 3 yrs. \$50.00. Combination Husband & Wife: \$30.00 per yr., 3 yrs. \$75.00. Youth Sanctioned Show - OFFICIAL ARBA YOUTH SANCTIONED SHOW, Membership Dues: \$12.00 per yr., 3 yrs. \$30.00. ARBA Executive Director, PO Box 400 Knox, PA 16232. ARBA website: www.arba.net.
- The next ARBA Convention and Annual Meeting will take place in Reno, NV on October 19-23, 2019.
- No changes or substitutions can be made at the show table, except for ear # changes in the same class. Other changes need to be taken care of at the secretary's table prior to the show.
- Animals showing symptoms of disease of any kind will not be allowed admittance to the show room.
- The decisions of the judges will be final. Exhibitors must act in a professional manner towards judges, show committee, show help and each other. This is expected of both adults and youth. Exhibitors attempting to or actually interfering with, annoying or trying to influence a judge, or behaving in an unbecoming manner will be rejected and barred from the show, forfeiting all entry fees.
- All stock must have a permanent and legible tattoo in the left ear.
- This is a carrier show. Carriers must have leak-proof bottoms.
- Only show officials, judges and designated help are allowed in the judging area.
- The show officials will determine the selection of judges and the order of judging. CSE reserves the right to substitute judges as needed. No special judging requests will be considered.
- Owners are responsible for getting their own rabbits to the show table.
- Rabbits will be called to the table 3 times only before being scratched.
- Interpretation of the show rules will be by the show officials.

Show Management: This show is a presentation of RJ Promotions, Inc., Country Club, Missouri, in cooperation with Colorado Springs Rabbit Breeders, LLC hereinafter referred to as "Show Management", shall have the right to hereby expressly reserve, to make such rules and regulations as it shall deem advisable for the success of the Show, and to change and amend the same from time to time, which shall govern the proper conduct of said Show and the use of this contract and the space herein reserved by the Exhibitor. The Show's Management application interpretation and construction of said rules and regulations shall be final and conclusive. Show Management assumes no responsibility for any understanding or representations made by any of its officers or agents prior to the execution of this Contract, unless such understanding or representations by Show Management are expressly stated in the Contract.

The Owner, Exhibitor, Associates, employees, their agents and/or representatives, hereinafter collectively referred to as "Participants".

AT NO TIME WILL SHOW MANAGEMENT ASSUME CARE, CUSTODY OR CONTROL OF ANY ANIMALS, LIVESTOCK AND/OR PERSONAL PROPERTY OF THE EXHIBITOR. AT ALL TIMES THE PARTICIPANTS WILL HAVE FULL CONTROL, CUSTODY AND WILL CARE, FEED AND KEEP SAFE THEIR ANIMALS, LIVESTOCK AND PERSONAL PROPERTY, ALL IN ACCORDANCE WITH THE RULES AND REGULATIONS OF BUILDING MANAGMENT AND THE SHOW MANAGEMENT. The Participants will be responsible and pay for any damages to Show Management premises, facilities or equipment caused by the Participants and/or their livestock while on the premises of Show Management.

Liability and Insurance:

- RJ Promotions, Inc. the publicized sponsor of said Show and the Building Management, either collectively, individually or otherwise, shall not in any way be liable nor shall they be required to maintain insurance for any damage or loss, regardless if the cause of the same, either to person or property, sustained by the Exhibitor and or his employees and representatives except that liability mandated by Building Management.
- The Participants agree to be responsible for and pay, indemnify, save and hold harmless Show Management, the Colorado Springs Event Center, the City of Colorado Springs, and County of El Paso against any and all loss, claims, cost and/or expenses, including reasonable attorneys' fees, resulting from any loss or any claims or legal action of any nature whatsoever, whether or not reduced to a judgment, for any liability of any nature whatsoever that may arise against the Stock Show as a result of the operation, and/or the use of the premises including any acts of the Participants, or invitees or in connection with any of the rights or privileges granted by Show Management to Participants, in the agreement and premium book, including any actions, without limitation, on any violation of patent, trademark, franchise, copyright, libel or defamation liability claim or suit including any claim or suit based upon the intentional, unintentional or negligent acts of the Participants or invitees. The Participants further warrant that all copyright materials, to be performed or used during the term of this agreement, have been duly licensed or authorized by their copyright owners or agents and Participants, agree to be responsible for all license and royalty fees incurred by reason of any performance or use of copyright materials and in addition to any provisions contained elsewhere in this agreement and premium book to indemnify and hold the Show Management harmless from any and all losses and expenses incurred with regard thereto. The Participants will not be obligated to indemnify, defend or hold Show Management harmless from any claim or demand which arises solely out of the negligent act or failure to act by Show Management, its officers or employees.
- In addition, Participants will indemnify and hold harmless the Show Management for all damages, expenses or liabilities incurred as a result of any expense, loss, claims, costs or any liability, including, but not limited to, consultant fees, legal or court costs, Show Management labor expenses and or costs, as well as expenses and or cost for blood, tissue, urine, hide and or carcass sampling and testing incurred as a result of Show Management rule and regulation violations and all agreements herein, including, but not limited to unethical fitting, filling, meat tampering, illegal or non-approved use of drugs, medication and or prohibited substances as a result of Participants involvement in the Show Management. Participants may also be subject to criminal charges.

If Participant is a minor, Participant's parent or guardian must sign the Colorado Springs Exposition entry forms acknowledging they have read the Colorado Springs Exposition Rules and Regulations and agree to observe and abide by these rules and regulations. Parent or guardian further acknowledges that they have read and explained to the Participant the Agreement of Responsibility and Liability and explained and cautioned the Participant on the penalties for prohibited substance, unethical fitting, sabotage and tampering of livestock.

If Exhibitor defaults on payment, Exhibitor is liable to RJ Promotions, Inc. for collection costs, including reasonable attorney's fees. For returned checks, a \$50 fee will be added to your account. In the event the applicant breaches any term or condition of this Application/ Agreement, including the collection of any moneys due from the applicant and RJ Promotions, Inc. incurs any costs and an expense, including a reasonable attorney and paralegal fee, the applicant agrees to pay any such costs, fees, and expenses incurred by RJ Promotions. This contract shall be governed by and interpreted using the laws of the State of Missouri, without regard to any conflict of law's provisions in any state or territory. Should either party to this agreement institute any suit or other legal proceeding involving the other party concerning any obligations in this agreement, such suit or legal proceeding shall solely, only and exclusively be filed in a Court located in Andrew County, Missouri, and no other. Exhibitor, its employees and representatives shall observe and comply with all Federal, State, Municipal and Building Management laws, charters, ordinances, rules and regulations of the State, City and Building in which said Show is presented.

The undersigned on behalf of himself/herself/itself and on behalf of his/her/its agents, servants and employees does hereby abide to the terms both on the front and back of said contract, releases and forever discharges RJ Promotions, Inc. and it's officers, directors, agents and employees from any physical or property damages or loss of income or any other damages incurred whether due to negligence of the undersigned, his/her/its agents, servants or employees, or the negligence of RJ Promotions, Inc. or any other person or entity.

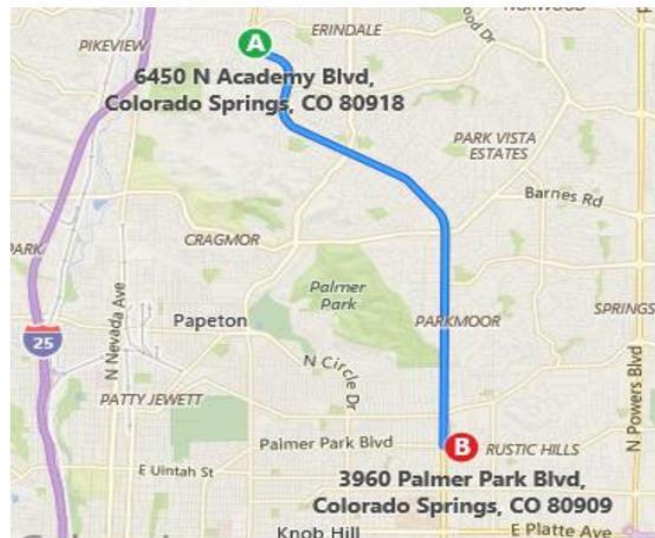
